**ORDER ON HUSBAND'S MOTION TO ORDER
INTENSIVE REUNIFICATION THERAPY FOR
MINOR CHILD AND FATHER**

THIS MATTER coming to be heard upon the Husband's Motion to Order Intensive Reunification Therapy for Minor Child and Father and this court having heard arguments of counsel and receiving information regarding the intensive reunification therapy in the above matter between the minor child, ██████ and the father, ██████

██████████ does hereby


ORDER

1. The Husband's Motion to Order Intensive Reunification Therapy for the Minor Child and Father is hereby granted.
2. The parties shall engage in intensive reunification therapy with Linda Gottlieb, located in Dutchess County, New York.
3. The child must be accompanied by an appropriate person to Dutchess County, New York.
4. The child must accompany the father, ████████████████████ on vacation in Dutchess County, New York for at least one week beginning Sunday, March 20, 2016.

5. The counselling shall take place between March 21 and March 25, 2016.
6. A temporary transfer of physical custody of the minor child, A.A., is hereby made to [REDACTED] with sole temporary custody beginning March 20, 2016.
7. There shall be a 90 day sequestration period between the child and the mother, [REDACTED]. This includes telephone and electronic communications as well as physical contact. This 90 day provision can be modified either to be increased or decreased at the sole discretion of Linda Gottlieb.
8. [REDACTED] shall accept parent counselling services with Linda Gottlieb telephonically.
9. [REDACTED] is to provide the child with a letter stating the importance of having her father, [REDACTED], in her life and in what specific ways she supports the reunification.
10. There shall be an indefinite extension of the no contact requirement should [REDACTED] fail to support [REDACTED] relationship with his child, A.A..
11. A Pretrial Conference date shall be set in this matter as soon as possible.
12. The parties are to share the expenses for Linda Gottlieb in the following manner:
 - a. The Father, [REDACTED] shall pay \$10,000 towards the fees of Linda Gottlieb; and
 - b. The Mother, [REDACTED] shall pay \$2,000 in fees for Linda Gottlieb's services.
13. Physical custody of the child, [REDACTED] shall be transferred to [REDACTED] on

the 20th day of March, 2016 for the purpose of travel to Dutchess County, New York and custody shall remain with [REDACTED] until Linda Gottlieb approves the ending of the sequestration period.
